**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of November 30, 2018, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Agent under the below-defined Security Agreement, having an office at 575 Market Street, 29<sup>th</sup> Floor, San Francisco, California 94105 ("Grantee") to **TRITON DIGITAL CANADA INC.**, a Québec corporation ("Grantor"), with its chief executive office at 1440 rue Sainte-Catherine W Montreal (Québec) H3G1R8.

WHEREAS, pursuant to that certain Confirmation of Hypothec and Security Interest (Trademarks) dated as of February 5, 2016, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 12, 2016, at Reel 5730 and Frame 0781; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement and terminate and release all of Grantee's interest to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall have the meaning as defined in the Security Agreement and shall include, without limitation, all of the Grantor's right, title and interest of every kind and nature as of the date hereof in, to and under the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
