**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release") is dated as of December 6, 2018 by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as Collateral Agent (in such capacity, together with its successors and assigns in such capacity, the "Agent") in favor of BRUNDAGE-BONE CONCRETE PUMPING, INC., a Colorado corporation and ECO-PAN, INC., a Colorado corporation (each, a "Grantor" and collectively, the "Grantors").

**WITNESSETH**

WHEREAS, the Grantors and the Agent entered into that certain Second Lien Security Agreement dated as of September 8, 2017 (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time prior to the date hereof, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered to the Agent that certain Trademark Security Agreement dated as of September 8, 2017 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office on September 11, 2017 at Reel/Frame Nos. 6151/0376 and 6151/0387, pursuant to which the Grantors granted, assigned, and pledged to the Agent a continuing security interest in all of their right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Grantors have requested that the Agent release its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in and to the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The Agent agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably required to evidence this Release. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.

The Agent is executing and delivering this Release not in its individual or corporate capacity, but solely in its capacity as Collateral Agent pursuant to that certain Indenture, dated as of September 8, 2017 (the "Indenture"), by and among Grantor, the guarantors party thereto, Agent, and Wilmington Trust, National Association, as trustee. In acting hereunder, the Agent shall have all of the rights, privileges, and immunities afforded to it as the Collateral Agent under the Indenture, including without limitation Article 7 thereof, as if such rights, privileges, and immunities were expressly fully set forth herein.


