## TERMINATION AND RELEASE OF SECURITY INTEREST

This TERMINATION AND RELEASE OF SECURITY INTEREST, effective as of December 20, 2018 (the "Release"), is made by Royal Bank of Canada, as administrative agent ("Administrative Agent") for the Secured Parties (as defined in the Second Lien Credit Agreement), in favor of Doherty Employment Group, Inc. (collectively, the "Grantors").

WHEREAS, pursuant to that certain **Second Lien Intellectual Property Security Agreement dated as of February 2, 2016** (as amended, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement") by and among the Grantor thereto and the Administrative Agent, for the benefit of the Secured Parties, a security interest was granted in, to and under certain intellectual property of the Grantor, including without limitation, Trademarks; and

WHEREAS, the IP Security Agreement was recorded with the U.S. Patent and Trademark Office ("PTO") on February 4, 2016 at Reel 5432, Frame 0444.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, hereby states as follows:

1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the IP Security Agreement.


2. Release of Security Interest. Administrative Agent, on behalf of the Secured Parties, hereby terminates, releases, cancels and discharges all of its security interest, liens and encumbrances in, to and under the intellectual property of the Grantor, including without limitation, Trademarks and Copyrights, and discharges and relinquishes unto Grantor, any and all right, title and interest it has in, to and under the intellectual property of the Grantors, including without limitation, Trademarks, and authorizes the recordation of this Release with the PTO.

3. Further Assurances. Administrative Agent, on behalf of the Secured Parties, hereby agrees to duly execute, acknowledge, deliver and procure any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest discussed herein.
