RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** ("Release"), dated as of December 21, 2018 from Texas Capital Bank, National Association ("Bank"), to TWR Lighting, Inc., a Texas corporation ("Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Grantor is party to that certain Trademark Security Agreement (as amended, modified, restated or supplemented from time to time, "Trademark Security Agreement") dated as of September 29, 2009, between Grantor and Bank, and that certain Patent Security Agreement, dated as of September 29, 2009, between Grantor and Bank (as amended, modified, restated or supplemented from time to time, together with the Trademark Security Agreement, "Security Agreements"), pursuant to which the Grantor granted to Bank a security interest in certain collateral, specifically Grantor's right, title and interest in and to the Intellectual Property, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Intellectual Property, including those set forth in Schedule A hereto ("Intellectual Property"); and

WHEREAS, the Bank now desires to terminate and release the entirety of its security interest in the Patents and Trademark as of November 29, 2018 (the "Effective Date").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby, without representation, warranty or recourse of any kind, terminates, discharges, cancels and releases any and all liens and security interests it has against the Intellectual Property.


The Bank shall take all further actions (including, the execution and delivery of any and all documents or other instruments), reasonably necessary to effect the release of the liens and security interests contemplated hereby, and at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
