Pledgor grants to the Administrative Agent a security interest in all of Pledgor's right, title and interest in and to the patent collateral and the trademark collateral as set forth on Schedules A and B hereto. All such collateral shall be deemed to be part of the Collateral and shall be hereafter subject to each of the terms and conditions of the Patent Security Agreement and Trademark Security Agreement.
