## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of January 14, 2019 in favor of HaystackID Holdings LLC, a Delaware limited liability company ("Holdings"), HaystackID LLC, a Delaware limited liability company (the "Company"), Flex Discovery LLC, a Delaware limited liability company ("Flex"), Inspired Review LLC, a Delaware limited liability company ("Inspired"), Envision Discovery, LLC, a North Carolina limited liability company ("Envision"; Holdings, the Company, Flex, Inspired and Envision are referred to herein, collectively, as "Grantors" and, individually, as a "Grantor"), by TCF National Bank, individually ("TCF"), and in its capacity as administrative agent (in such capacity, the "Administrative Agent") for the lenders from time to time party to the Credit Agreement referred to in the 2018 Security Agreement (as defined below).

WHEREAS, pursuant to the terms and conditions of (a) that certain Patent, Copyright and Trademark Security Agreement, dated as of April 4, 2018 (the "2018 Security Agreement"), executed by Grantors and HaystackID Review LLC, a Delaware limited liability company ("Review"; Review was dissolved pursuant to a Certificate of Cancellation filed with the Secretary of State of Delaware on September 7, 2018) in favor of the Administrative Agent, each Grantor granted to the Administrative Agent a security interest in all of such Grantor's right, title and interest in and to its intellectual property, including, but not limited to, the trademark applications and registrations set forth on Schedule 1 attached hereto (collectively the "Intellectual Property Collateral"), and (b) that certain Patent, Copyright and Trademark Security Agreement, dated as of October 11, 2017 (the "2017 Security Agreement"; together with the 2018 Security Agreement, collectively, the "Security Agreements" and, individually, a "Security Agreement"), executed by Holdings, the Company, Flex and Review in favor of TCF, Holdings, the Company, Flex and Review granted to TCF a security interest in all of such Grantor's right, title and interest in and to certain of the Intellectual Property Collateral;

WHEREAS, the 2018 Security Agreement was recorded with the United States Patent and Trademark Office on April 9, 2018 at Reel/Frame 6309/0117, and the 2017 Security Agreement was recorded with the United States Patent and Trademark Office on October 11, 2017 at Reel/Frame 6180/0238.

WHEREAS, each of TCF and the Administrative Agent wishes to release its security interest in the Intellectual Property Collateral and reassign to each Grantor all of TCF's and the Administrative Agent's right, title and interest in and to the Intellectual Property Collateral of such Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of TCF and the Administrative Agent hereby terminates the 2018 Security Agreement and the 2017 Security Agreement, and hereby terminates, cancels and releases any security interest it may have in the Intellectual Property Collateral and reassigns to each Grantor any rights it may have in the Intellectual Property Collateral.

TCF and the Administrative Agent shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release. Each Grantor is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
