RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release") is effective as of October 5, 2018, by PNC Bank, National Association, in its capacity as Collateral Agent and Administrative Agent (in such capacities, "Secured Party").

WHEREAS, pursuant to that certain Patent, Copyright and Trademark Security Agreement, dated as of May 10, 2018, by Aerostructures Acquisition LLC, a Delaware limited liability company ("Parent"), Vitron Acquisition Corporation, a Delaware corporation ("Vitron Corp."), Vitron Acquisition LLC, a Delaware limited liability company ("Vitron LLC"), Atlas Aerospace, LLC, a Delaware limited liability company ("Atlas"), Brenner Aerostructures, LLC, a Pennsylvania limited liability company ("Brenner" and together with Parent, Vitron Corp., Vitron LLC and Atlas, collectively, the "Grantors" and each "Grantor").in favor of Secured Party (the "Security Agreement"), each Grantor granted to Secured Party a continuing security interest in and continuing lien upon all of the Intellectual Property Collateral (as defined in the Security Agreement) of such Grantor, including, without limitation, the trademarks listed on Exhibit A hereto (collectively, the "Trademarks"); and

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on May 16, 2018 at Reel/Frame 6331/0862.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Secured Party hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Intellectual Property Collateral, without any recourse, representation or warranty, (ii) terminates the Security Agreement, and (iii) re-assigns to the Grantors, any right, title or interest the Secured Party may have in, to or under the Intellectual Property Collateral, together with the goodwill of the business symbolized thereby, and hereby authorizes the Grantor or the Grantors' authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.


Terms used and not otherwise defined herein shall have the meaning given to such terms in the Security Agreement.
