RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of November 6, 2018 is made by GOLDMAN SACHS BANK USA, in its capacity as collateral agent (in such capacity, the "Agent"), in favor of LINEAGE LOGISTICS HOLDINGS, LLC, a Delaware limited liability company, CITYICE COLD STORAGE, LLC, a Washington limited liability company (as successor-in-interest by merger with City Ice Cold Storage Company, a Washington corporation), RICHMOND COLD STORAGE COMPANY, LLC, a Georgia limited liability company (as successor-in-interest by merger with Richmond Cold Storage Company, Incorporated, a Virginia corporation), and SEAFREEZE ACQUISITION, LLC, a Delaware limited liability company (collectively, the "Grantors" and individually, a "Grantor").

W I T N E S S E T H:

WHEREAS, in connection with the Guarantee and Collateral Agreement, dated as of April 26, 2013, among the Agent, the Grantors and the other parties thereto (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), the Grantors executed and delivered the Trademark Security Agreement, dated as of April 26, 2013, in favor of the Agent (the "Trademark Security Agreement");

WHEREAS, an executed copy of the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on May 2, 2013, at Reel/Frame No. 5025/0210; and

WHEREAS, the Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent agrees as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Collateral Agreement and Trademark Security Agreement, as applicable (it being understood that, unless otherwise provided, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Collateral Agreement).

2. Release of Security Interest. The Agent does hereby terminate the Trademark Security Agreement and discharge and release any and all security interest in, lien upon and conditional assignment of the Trademark Collateral, and reassigns to Grantors any and all right, title and interest in, to and under the Trademark Collateral, including but not limited to the trademarks more fully identified on Exhibit A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind.

3. Purpose. The Agent does hereby authorize the Grantors and their designees and agents to record this Release with the United States Patent and Trademark Office at the sole

expense of the Grantors and agree to provide the Grantors with any information and additional authorization necessary to effect the release of the Security Interest in the Trademark Collateral.
