## GRANT OF SECURITY INTEREST

THIS GRANT OF SECURITY INTEREST, dated as of November 9, 2018, is executed by BALLISTIC ADVANTAGE, LLC, a Delaware limited liability company ("Grantor"), in favor of WELLS FARGO BANK, NATIONAL ASSOCIATION ("Bank").

A. Pursuant to that certain Credit Agreement dated as of the date hereof (as amended, restated, supplemented, and modified from time to time, the "Credit Agreement"), by and between FALL MACHINE COMPANY, LLC, a Delaware limited liability company ("Borrower"), and Bank, Bank has agreed to extend certain credit facilities to Borrower upon the terms and subject to the conditions set forth therein.

B. Grantor owns the trademarks more particularly described on Schedule 1-A annexed hereto as part hereof (collectively, the "Intellectual Property");

C. Grantor has entered into an Intellectual Property Security Agreement of even date herewith (the "Security Agreement") in favor of Bank; and

D. Pursuant to the Security Agreement, Grantor has granted to Bank a security interest in all right, title, and interest of Grantor in and to the Intellectual Property, together with any reissue, continuation, continuation-in-part, or extension thereof, and all proceeds thereof, including any and all causes of action that may exist by reason of infringement thereof for the full term of the Intellectual Property (collectively, the "Collateral"), to secure the prompt payment, performance, and observance of the Obligations, as defined in the Security Agreement;

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby further grant to Bank a security interest in the Collateral to secure the prompt payment, performance, and observance of the Obligations.


