INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION (the “**Termination Agreement**”) is made effective as of January 24, 2019, by and from OPUS BANK (“**Bank**”), under the Amended and Restated General Security Agreement, dated as of February 27, 2015, between LUNERA LIGHTING, INC., a Delaware corporation (“**Grantor**”), and Bank, to Grantor as follows:

WHEREAS, Grantor and Bank entered into the Intellectual Property Security Agreement, dated as of March 30, 2013 (the “**Intellectual Property Security Agreement**”; capitalized terms used but not defined herein shall have the meanings given them in the Intellectual Property Security Agreement) and the IP Supplement to Intellectual Property Security Agreement, dated as of February 21, 2017 (the “**IP Supplement Agreement**”);

WHEREAS, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on March 25, 2013, at Reel 030074 and Frame 0827 for patents and at Reel 4988 and Frame 0384 for trademarks and the IP Supplement Agreement was recorded in the United States Patent and Trademark Office on February 24, 2017, at Reel 041372 and Frame 0549 for patents and at Reel 5999 and Frame 0034 for trademarks;

WHEREAS, pursuant to the Intellectual Property Security Agreement and the IP Supplement Agreement, Grantor granted Bank a security interest in all of Grantor’s right, title and interest in, to and under the patents listed on the attached **Exhibit A** and all pending patents and patents acquired or arising after the date of the Intellectual Property Security Agreement (the **Patents**), and the trademarks listed on the attached **Exhibit B** (the “**Trademarks**”) and all trademark applications, trademark registrations, pending patents and patents acquired or arising after the date of the Intellectual Property Security Agreement (the **Patents**, the **Trademarks** and such other intellectual property the “**Intellectual Property**”);

WHEREAS, Grantor has or has caused to be paid and satisfied in full the obligations for which the security interest in the Intellectual Property was granted pursuant to a certain letter dated as of April 19, 2017 (the “**Payoff Letter**”); and

WHEREAS, the Bank wishes to release its security interest in the Intellectual Property.

NOW, THEREFORE, that pursuant to the Payoff Letter, the parties agree that Bank hereby releases any security interest it may have in the Intellectual Property and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns to Grantor all right, title and interest in the Intellectual Property it may have in and to the foregoing without recourse to Grantor.
