**RELEASE OF SECURITY INTEREST UNDER FIRST PRIORITY TRADEMARK
SECURITY AGREEMENT AND INTELLECTUAL PROPERTY SECURITY
AGREEMENT**

THIS RELEASE OF SECURITY INTEREST UNDER FIRST PRIORITY TRADEMARK SECURITY AGREEMENT AND INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release"), is dated as of November 8, 2018, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **HERITAGE HOME GROUP LLC** ("Heritage"), a Delaware limited liability company, and **HHG GLOBAL DESIGNS LLC**, a Delaware limited liability company ("Global" and together with Heritage, collectively, the "Grantors").

WHEREAS, pursuant to that certain First Priority Trademark Security Agreement dated as of March 13, 2017, made by Global in favor of Grantee ("2017 Security Agreement"), and that certain Intellectual Property Security Agreement dated as of July 31, 2018, made by the Grantors in favor of Grantee ("2018 Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the 2017 Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office ("USPTO") on March 16, 2017 at Reel/Frame 6011/0660 and the 2018 Security Agreement was recorded with the trademark division of the USPTO on August 16, 2018 at Reel/Frame 6417/0009; and

WHEREAS, Grantee now desires to terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.
2. Release of Security Interest. Grantee hereby terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.


