RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST dated as of January 24, 2019 (this "***IP Security Release***"), by BANK OF AMERICA, N.A. Reference is made to (a) that certain Trademark Security Agreement dated as of October 24, 2002 (the "***2002 Security Agreement***"), between Simmons Outdoor Corporation, a Delaware corporation and the Administrative Agent, (b) that certain Intellectual Property Security Agreement dated as of March 31, 2004 (the "***2004 Security Agreement***"), by the Persons on the signature pages thereof in favor the Administrative Agent, (c) that certain Intellectual Property Security Agreement dated October 7, 2010 (the "***2010 Security Agreement***"), by the Persons listed on the signature pages thereof in favor of the Administrative Agent, (d) that certain Intellectual Property Security Agreement Supplement dated as of March 31, 2012 (the "***2012 Security Agreement***"), by the Person listed on the signature page thereof in favor of the Administrative Agent and (e) that certain Intellectual Property Security Agreement dated as of November 1, 2013 (together with the 2002 Security Agreement, the 2004 Security Agreement, the 2010 Security Agreement and the 2012 Security Agreement, the "***Security Documents***"), by the Persons listed on the signature pages thereof in favor of the Administrative Agent.

WHEREAS, pursuant to the terms and conditions of the Security Documents, the Grantors granted to the Administrative Agent a security interest in and to all of such Grantor's right, title and interest in, to and under any and all of the following (collectively, the "***Released IP Collateral***"):

- (a) the patents and patent applications set forth on Schedule A hereto;
- (b) the trademark and service mark registrations and applications set forth on Schedule B hereto; and
- (c) the copyright registrations and applications set forth on Schedule C hereto.

WHEREAS, the security interest in the Released IP Collateral was recorded with the United States Patent and Trademark Office on October 24, 2002 at Reel/Frame 2636/0397, on March 31, 2004 at Reel/Frame 14722/962, Reel/Frame 14729/950 and Reel/Frame 14713/253, on October 7, 2010 at Reel/Frame 4408/704 and Reel/Frame 25321/291, on March 31, 2012 at Reel/Frame 4767/0759 and Reel/Frame 28132/164, and on November 1, 2013 at Reel/Frame 5167/252, Reel/Frame 31731/281 and Reel/Frame 31765/300, and with the United States Copyright Office on November 1, 2013 at Volume/Document No. 9907/480.

WHEREAS, Administrative Agent now desires to execute and deliver this IP Security Release to evidence the release of its lien on and security interest in and to the Released IP Collateral identified in Schedules A, B, and C attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent and the Grantors hereby

agree as follows:

SECTION 1. Release of Security Interest. The Administrative Agent does hereby release and convey to the Grantors, without recourse, representation or warranty of any kind, all of the Administrative Agent's right, title and interest in and to each Grantor's right, title and interest in and to the Released IP Collateral identified in Schedules A, B, and C attached hereto.

SECTION 2. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 3. Miscellaneous. The Administrative Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to make filings with the United States Patent and Trademark Office and the United States Copyright Office and other necessary filings, in each case at the expense of the Borrower, to evidence the release and termination of the Administrative Agent's security interests in the Released IP Collateral.
