INTELLECTUAL PROPERTY SECURITY AGREEMENT

INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of January 31, 2019 (this “**Agreement**”), among A&AT LLC, a Delaware limited liability company (“**Grantor**”) and WILMINGTON TRUST (LONDON) LIMITED, as security agent for the Secured Parties (in such capacity, the “**Security Agent**”).

RECITALS

Grantor is party to that certain Pledge and Security Agreement, dated as of January 31, 2019 (as it may from time to time be amended, restated, supplemented or otherwise modified in accordance with its terms, the “**Pledge and Security Agreement**”), among others, Ruyi US Finance LLC, a Delaware limited liability company, Ruyi US Acquisition Parent Corp., a Delaware corporation, Ruyi US Acquisition Corp., a Delaware corporation and the Security Agent, pursuant to which Grantor is required to execute and deliver this Agreement.

In consideration of the conditions and agreements set forth in the Facility Agreement, the Indenture, the Pledge and Security Agreement and this Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

Section 1.1 Defined Terms

Unless otherwise defined herein, terms defined in the Pledge and Security Agreement and used herein have the meaning given to them in the Pledge and Security Agreement.

Section 2.1 Grant of Security Interest in Intellectual Property Collateral

As security for the prompt and complete payment and performance in full when due (whether at stated maturity, by required prepayment, declaration, acceleration or otherwise) of all Secured Obligations, Grantor hereby pledges, collaterally assigns and grants to the Security Agent, for the benefit of the Secured Parties, a continuing security interest in and Lien on all of its right, title and interest in, to and under all Intellectual Property Collateral (as defined below), whether now owned or hereafter acquired or existing and wherever located.

“**Intellectual Property Collateral**” means Grantor’s right, title and interest in, to and under all of the following property (other than any Excluded Property):

(a) all Copyrights owned by or licensed to Grantor, including those material U.S. federal Copyright applications and registrations referred to on Schedule I hereto;

(b) all Patents owned by or licensed to Grantor, including those material U.S. federal Patents and Patent applications referred to on Schedule II hereto;

(c) all Trademarks owned by or licensed to Grantor, including those material U.S. federal Trademark applications and registrations referred to on Schedule III hereto, together with all goodwill of the business connected with the use of, and symbolized by, each such Trademark;

(d) all material Intellectual Property Licenses to which Grantor is a party, including those material exclusive copyright licenses to which the Grantor is a licensee, referred to on Schedule I hereto;

(e) all reissues, continuations or extensions of the foregoing; and

(f) all Proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement or, if applicable, dilution of any owned or licensed Copyright, Trademark or Patent, or (ii) injury to the goodwill associated with any owned or licensed Trademark.

Section 3.1 Certain Exclusions

Notwithstanding anything herein to the contrary, in no event will the Intellectual Property Collateral include and Grantor will not be deemed to have granted a Security Interest in any of its right, title or interest in any Excluded Property.

Section 4.1 Pledge and Security Agreement

The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Security Agent pursuant to the Pledge and Security Agreement, and Grantor hereby acknowledges and affirms that the rights and remedies of the Security Agent with respect to the security interest granted by them in the Intellectual Property Collateral made and granted hereby are more fully set forth in the Pledge and Security Agreement. To the extent applicable for purposes of this Agreement, the terms and provisions of the Pledge and Security Agreement are incorporated by reference herein. To the extent there is any conflict between the terms of this Agreement and the Pledge and Security Agreement, the Pledge and Security Agreement shall control.


Section 5.1 Governing Law


