**RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

November 5, 2018

WHEREAS, pursuant to that certain Trademark Security Agreement dated June 19, 2018 (the "**Trademark Security Agreement**") and recorded in the United States Patent and Trademark Office on June 21, 2018, at Reel/Frame 6359/0923, Sole Society Group, Inc. ("**Grantor**") assigned to and granted to The CIT Group/Commercial Services, Inc., as administrative agent and collateral agent for lenders ("**Agent**"), a security interest in all right, title and interest of Grantor in and to the Trademark Collateral (as defined in the Trademark Security Agreement), which includes without limitation the trademark registrations and applications listed on Schedule A hereto together with the goodwill of the business symbolized by such trademark registrations and applications; and

WHEREAS, Agent wishes to provide a document (this "**Trademark Release**") suitable for recording in the United States Patent and Trademark Office (the "**USPTO**") the release, relinquishment and discharge of its security interest in the Trademark Collateral;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Agent agrees, for the benefit of Grantor, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used herein have the meanings provided or provided by reference in the Trademark Security Agreement.

SECTION 2. Release of Security Interest. Agent did and hereby does relinquish, release and discharge its security interest in the Trademark Collateral, and hereby assigns, transfers and conveys to Grantor, any right, title, or interest it may have in the Trademark Collateral. Agent hereby authorizes Grantor or Grantor's authorized representative to record this Trademark Release with the USPTO.
