**PARTIAL TERMINATION AND RELEASE OF LIEN IN TRADEMARK APPLICATIONS**

**THIS PARTIAL TERMINATION AND RELEASE OF LIEN IN TRADEMARK APPLICATIONS** (this "Release"), is dated as of August 27, 2018, and made by PNC Bank, National Association, in its capacity as administrative agent (the "Administrative Agent").

WHEREAS, pursuant to that certain Supplement to Patent, Trademark and Copyright Security Agreement dated as of June 29, 2018 (the "Security Agreement Supplement"), made by Black Box Corporation, a Delaware corporation ("Black Box"), and the other Grantors (as defined therein) party thereto, in favor of the Administrative Agent, a security interest was granted by Black Box to the Administrative Agent in certain collateral, including the Specified IP Collateral (as hereinafter defined);

WHEREAS, the Security Agreement Supplement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 3, 2018, at Reel 6370 and Frame 0400;

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in the Specified IP Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Definitions. The term "Specified IP Collateral," as used herein, means all of Black Box's right, title and interest in the trademark applications listed on Schedule A hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its security interest in the Specified IP Collateral and reassigns to the person or persons legally entitled thereto all of its right, title and interest in the Specified IP Collateral. The Administrative Agent acknowledges that this Release may be filed with the United States Patent and Trademark Office or any other governmental office to evidence the partial termination and release granted by this Release.
