**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of December 14, 2018, by ANTARES CAPITAL LP, as Administrative Agent for certain lenders (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Plaskolite Texas, LLC, an Ohio limited liability company (“Grantor”) and Secured Party were parties to that certain Notice of Security Interest in Trademarks dated as of November 3, 2015 (the “Security Agreement”) pursuant to which the Grantor granted a security interest to Secured Party in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on November 3, 2015, at Reel 5659, Frame 0251;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
