**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of February 7, 2019, by MB Financial Bank, N.A. ("Lender") in favor of Aero Precision, LLC, a Delaware limited liability company ("Borrower").

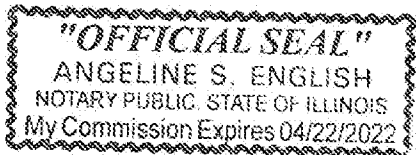
