**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of January 30, 2019 (the “Effective Date”) by ENTERPRISE BANK & TRUST, a Missouri chartered trust company (the “Secured Party”) in favor of RKD GROUP HOLDINGS, LLC (formerly known as LW ROBBINS, LLC), a Delaware limited liability company, RKD GROUP, INC. (formerly known as RobbinsKersten Direct, Inc.), a Massachusetts corporation, and RKD GROUP, LLC (formerly known as RobbinsKersten Direct, Inc.), a Delaware limited liability company (collectively, “Debtor”).

WHEREAS, Secured Party and Debtor are parties to that certain Loan and Security Agreement dated as of September 30, 2015 (together with all amendments thereto, the “Loan Agreement”); and

WHEREAS, in connection with the Loan Agreement, Debtor executed and delivered in favor of Secured Party that certain Trademark Security Agreement dated as of September 30, 2015, which was recorded with the United States Patent and Trademark Office on October 23, 2015 at Reel/Frame 5651/0552, as amended by that certain First Amendment to Trademark Security Agreement dated as of December 18, 2017, which was recorded with the United States Patent and Trademark Office on December 19, 2017 at Reel/Frame 6233/0943, and as further amended by that certain Second Amendment to Trademark Security Agreement dated as of May 9, 2018, which was recorded with the United States Patent and Trademark Office on May 16, 2018 at Reel/Frame 6387/0258 (collectively, the “Trademark Security Agreement”); and

WHEREAS, pursuant to the Trademark Security Agreement, Debtor pledged and granted to the Secured Party a Security Interest in Debtor’s right, title and interest in, to and under all of the trademarks owned by Debtor including, without limitation, the trademarks set forth on Schedule A attached hereto (collectively, the “Trademarks”); and

WHEREAS, Debtor has paid all of its outstanding indebtedness to the Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates the Trademark Security Agreement and the Loan Agreement, and hereby terminates, cancels and releases any and all security interests it has in, to and under the Trademarks.
