**Notice of Grant of Security Interest in Trademarks**

NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS, dated as of December 31, 2018 (this “Notice”), made by EARTHLINK, LLC, a Delaware limited liability company (the “Pledgor”), in favor of HPS INVESTMENT PARTNERS, LLC, as Collateral Agent (as defined below).

Reference is made to the Collateral Agreement, dated as of December 31, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among Eagle NT NewCo, LLC, a Delaware limited liability company (“Merger Sub”) which, on the Closing Date, will be merged with and into Earthlink, LLC, a Delaware limited liability company, as the borrower (the “Borrower”), Earthlink Holdings, LLC, a Delaware limited liability company (“Holdings”), the subsidiaries of the Borrower identified therein and HPS Investment Partners, LLC, as collateral agent (together with its successors and assigns in such capacity, the “Collateral Agent”) for the Secured Parties (as defined therein). The parties hereto agree as follows:

**SECTION 1. Terms.** Capitalized terms used in this Notice and not otherwise defined herein have the meanings specified in the Collateral Agreement. The rules of construction specified in Section 1.01(b) of the Collateral Agreement also apply to this Notice.

**SECTION 2. Grant of Security Interest.** As security for the payment and performance, as applicable, in full of the Secured Obligations, the Pledgor pursuant to the Collateral Agreement did, and hereby does, assign and pledge to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a continuing security interest in all of such Pledgor’s right, title and interest in, to and under any and all of the following assets now owned or held or at any time hereafter owned, held or acquired by such Pledgor or in which such Pledgor now has or at any time in the future may own, hold or acquire any right, title or interest (collectively, including the right to receive or sue for past, present or future damages, but excluding any Excluded Property, the “Trademark Collateral”):

all Trademarks, including those listed on Schedule I and all goodwill associated therewith;

provided that the foregoing pledge, assignment and grant of security interest will not cover any “intent-to-use” applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. §1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of the Lanham Act has been filed and accepted by the United States Patent and Trademark Office, to the extent, if any, that, and solely during the period, if any, in which the grant of a security interest therein would impair the validity or enforceability of such intent-to-use application under applicable federal law.

**SECTION 3. Collateral Agreement.** The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Collateral Agreement. Each Pledgor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Notice and the Collateral Agreement, the terms of the Collateral Agreement shall govern.

**SECTION 4. Cooperation by Borrower.** The Pledgor consents to the Collateral Agent filing of this Notice in the United States Patent & Trademark Office for patents and trademarks and further agrees to execute all documents reasonably required by Collateral Agent in order to effectuate this grant of security interest.


SECTION 5. **Recordation.** Each Pledgor authorizes and requests that the register for United States Patent & Trademark Office for patents and trademarks and any other applicable government officer record this Notice. This Notice does not create an ownership interest of the Collateral Agent or the Lenders in the Trademark Collateral.

SECTION 6. **Governing Law.** THIS NOTICE AND ANY CLAIMS, CONTROVERSY, DISPUTE OR CAUSES OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS NOTICE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS NOTICE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO ANY PRINCIPLE OF CONFLICTS OF LAW THAT COULD REQUIRE THE APPLICATION OF ANY OTHER LAW.
