ASSIGNMENT OF TRADEMARKS



ASSIGNOR further authorizes the relevant trademark offices worldwide to record the TRADEMARKS as property of ASSIGNEE; and


ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARKS.
