RELEASE OF SECURITY AGREEMENT

WHEREAS, **CATTRON GROUP INC. and CATTRON-THEIMEG, INC.**, (collectively, "GRANTORS") entered into a certain Intellectual Property Security Agreement dated May 22, 2003 (the "2003 SECURITY AGREEMENT"), between GRANTORS and **ARGOSY INVESTMENT PARTNERS II, L.P.**, ("ARGOSY" or "SECURED PARTY"), as recorded in the United States Patent and Trademark Office on July 14, 2003 at Reel 014262 and Frame 0950 and Reel 2778 and Frame 0503, and as recorded in the United States Copyright Office on August 11, 2003 under document V3500D289;

WHEREAS, in the 2003 SECURITY AGREEMENT, GRANTORS granted and pledged to SECURED PARTY "a security interest in all of GRANTORS' right, title and interest in, to and under the Copyrights, Patents and Trademarks listed on Exhibits A, B, and C hereto ("INTELLECTUAL PROPERTY"), and including without limitation all goodwill associated therewith, all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof";

WHEREAS, the SECURED PARTY desires to release its security interest in the INTELLECTUAL PROPERTY and terminate the 2003 SECURITY AGREEMENT;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, SECURED PARTY hereby:

1. releases, discharges and reassigns to GRANTORS any and all liens, security interest, right, title and interest of SECURED PARTY in the INTELLECTUAL PROPERTY more fully described on Exhibits A, B, and C, including without limitation the 2003 SECURITY INTEREST;
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given; and
3. authorizes and requests the Register of Copyrights of the United States of America to note and record the existence of the release hereby given;

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
