WHEREAS, each Grantor is party to a Debtor-in Possession Guarantee and Collateral Agreement, dated as of November 29, 2018 (as amended, supplemented, restated and/or otherwise modified from time to time, the “Security Agreement”) and to a Trademark Security Agreement of even date therewith in favor of the Releasor (as amended, supplemented, restated and/or otherwise modified from time to time, the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor granted to the Releasor, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of such Grantor’s Obligations, for the ratable benefit of the Credit Parties, a security interest in all of the Trademark Collateral, including, but not limited to, the trademark registrations and trademark applications listed on Schedule I attached hereto (the “Trademark Security Interest”);

WHEREAS, pursuant to the Security Agreement, each Grantor executed and delivered to the Releasor the Trademark Security Agreement, which was recorded at the U.S. Patent and Trademark Office (the “USPTO”) on December 4, 2018 at Reel/Frame 6493/0775;

WHEREAS, each of the Grantors has satisfied in full the terms of the Security Agreement and the Trademark Security Agreement and request a release of the Trademark Security Interest; and

WHEREAS, the Releasor, on behalf of itself and the Credit Parties, desires to terminate and grant a release of the Trademark Security Interest as provided in this Release.

NOW THEREFORE, in consideration of the foregoing premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the Releasor, on behalf of itself and the Credit Parties, agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable.

SECTION 2. Termination and Release. The Releasor, on behalf of itself and the Credit Parties, hereby absolutely, unconditionally and irrevocably (a) terminates the Trademark Security Agreement, (b) terminates, cancels, discharges, relinquishes and releases the Trademark Security Interest granted pursuant to the Security Agreement and/or the Trademark Security Agreement and (c) terminates all of the Releasor’s and the Credit Parties’ right, title and interest in, to and under such Trademark Collateral. The Releasor, on behalf of itself and the Credit Parties, authorizes and requests the recordation of this Release

against the Trademark Collateral with the USPTO and any other applicable governmental authority at the Grantors' expense.

SECTION 3. Further Assurances. At the request and sole expense of the Grantors, the Releasor, on behalf of itself and the Credit Parties, agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary and/or reasonably requested by any Grantor to carry out the purposes of this Release.

SECTION 4. GOVERNING LAW. THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK (AND, TO THE EXTENT APPLICABLE, THE BANKRUPTCY CODE), WITHOUT REGARD TO PRINCIPLES OF CONFLICTS OF LAWS, BUT INCLUDING SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW.

SECTION 5. Miscellaneous. This Release shall be binding upon the Releasor's and the Credit Parties' representatives, successors, assigns and transferees and is made in favor of and for the benefit of each Grantor and their respective successors and assigns.
