RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 6, 2019, is made by **BANK OF AMERICA, N.A.**, a national banking association, as administrative agent for the Lenders (as defined below) ("Grantee"), in favor of **CAMERON ASHLEY BUILDING PRODUCTS, INC.**, a Georgia corporation, formerly known as Guardian Building Products, Inc. WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of April 18, 2018, by and among Grantor, the Subsidiaries of Grantor signatory thereto as "Borrowers", **GBP HOLDING CORP.**, a Delaware corporation, **SC PROPCO LLC**, a Delaware limited liability company, **CAMERON ASHLEY BP MISSOURI PROPERTY, LLC**, a Delaware limited liability company, and any other Persons signatory thereto as "Guarantors", the Lenders, and Grantee, Grantor granted to Grantee a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule 1 to that certain Notice of Grant of Security Interest in Trademarks, dated as of April 18, 2018, given by Grantor in favor of Grantee (the "IP Agreement") and attached hereto as Schedule A (the "Released Trademarks");

WHEREAS, the IP Agreement was duly recorded on April 27, 2018, at Reel 6349, Frame 0679 in the United States Patent and Trademark Office;


WHEREAS, the Grantee wishes to release and restore all right, title and interest in and dissolve those liens and encumbrances created by the IP Agreement, without representation or warranty.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases, assigns and conveys, without recourse or warranty to Grantor all of its rights, title and interest in the Released Trademarks, and terminates, releases, discharges, quitclaims and relinquishes unto Grantee any and all security interests and liens it has against the Released Trademarks.
