## RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST** (this “**Release**”), dated as of March 8, 2019, is entered into between **BANK OF AMERICA, N.A.**, as agent for the Secured Parties (in such capacity, the “**Assignor**”) and **DAYTON SUPERIOR CORPORATION**, a Delaware Corporation (the “**Assignee**”).

### W I T N E S S E T H:

WHEREAS, Assignee, the financial institutions party thereto as lenders, the other Obligors party thereto and the Assignor entered into that certain Loan and Guaranty Agreement, dated as of October 26, 2009 (as amended and restated in that certain Amended and Restated Credit Agreement dated as of June 28, 2012, by the financial institutions party thereto as lenders, the other Obligors party thereto and the Assignor, and as further as amended, restated or otherwise modified prior to the date hereof, the “**Existing Credit Agreement**”);

WHEREAS, the Assignee, the other Grantors party thereto and the Assignor are parties to that certain Pledge and Security Agreement, dated as of October 26, 2009 (as amended, supplemented, or otherwise modified from time to time, the “**Security Agreement**”) pursuant to which each Grantor granted to the Assignor a security interest and continuing lien on all of such Grantor’s right, title and interest in, to and under all Collateral, including the Trademark Collateral (as defined below), in each case whether now owned or existing or hereafter acquired or arising and wherever located, to secure the prompt and complete payment and performance of all Secured Obligations;

WHEREAS, the Existing Credit Agreement was amended and restated in that certain Second Amended and Restated Credit Agreement dated as of July 30, 2015 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Second Amended and Restated Credit Agreement**”) by the financial institutions party thereto as lenders, the other Obligors party thereto and the Assignor;

WHEREAS, certain Grantors entered into a new Reaffirmation Agreement and Amendment to Pledge and Security Agreement (the “**Reaffirmation Agreement**”), dated as of July 30, 2015, under which the Reaffirming Parties (as defined in the Reaffirmation Agreement) agreed, among other things, to reaffirm the Reaffirmed Agreements (as defined in the Reaffirmation Agreement) to which they are a party, the Liens granted thereunder and the other rights and obligations of each Person party thereto;

WHEREAS, Assignor and Assignee have entered into that certain Trademark Security Agreement, dated as of October 26, 2009, and recorded on October 30, 2009 with the United States Patent and Trademark Office at reel 4088, frame 0454 (the “**2009 Trademark Security Agreement**”), that certain Supplemental Trademark Security Agreement, dated as of September 28, 2010, and recorded on September 30, 2010 with the United States Patent and Trademark Office at reel 4286, frame 0956 (the “**2010 Trademark Security Agreement**”), that certain Trademark Security Agreement, dated as of June 28, 2012, and recorded on July 27, 2012 with the United States Patent and Trademark Office at reel 4830, frame 0637 (the “**2012 Trademark Security Agreement**”), that certain Supplemental Trademark Security Agreement, dated as of May 1, 2014, and recorded on May 1, 2014, with the United States Patent and Trademark Office at reel 5272, frame 0316 (the “**2014 Trademark Security Agreement**”) and that certain Trademark Security Agreement, dated as of July 30, 2015, not recorded with the United States Patent and Trademark Office (the “**2015 Trademark Security Agreement**”, together with the

2009 Trademark Security Agreement, the 2010 Trademark Security Agreement, the 2012 Trademark Security Agreement, the 2014 Trademark Security Agreement, the “**Trademark Security Agreements**”); and

WHEREAS, Assignor wishes to release and terminate its security interest and continuing lien on all of each Grantor’s right, title and interest in, to and under all Trademark Collateral.

NOW, THEREFORE, in consideration of the premises and the agreements, provisions and covenants herein contained, Assignor agrees as follows:

Section 1. Defined Terms.

Unless otherwise defined herein, capitalized terms defined in the Security Agreement or the Trademark Security Agreements and used herein have the meaning given to them in the Security Agreement or Trademark Security Agreements, as applicable.

Section 2. Termination and Release. Assignor, without representation or warranty, hereby:

(a) terminates, cancels, discharges and releases the security interest and continuing lien on all of each Grantor’s right, title and interest in, to and under the following (collectively, the “**Trademark Collateral**”): all United States, State and foreign trademarks, service marks, certification marks, collective marks, trade names, corporate names, d/b/as, business names, fictitious business names, Internet domain names, trade styles, logos, other source or business identifiers, designs and general intangibles of a like nature and, with respect to any and all of the foregoing: (i) all registrations and applications therefor including, but not limited to, the registrations and applications referred to in Schedule I hereto, (ii) the goodwill of the business symbolized thereby, (iii) all rights corresponding thereto throughout the world, (iv) all rights to sue for past, present and future infringement or dilution thereof or for any injury to goodwill, (v) all licenses, claims, damages, and proceeds of suit arising therefrom, and (vi) all payments and rights to payments arising out of the sale, lease, license, assignment or other disposition thereof; and

(b) authorizes the recordation of this Release with the United States Patent and Trademark Office.

Section 3. GOVERNING LAW

THIS RELEASE SHALL BE GOVERNED BY THE LAWS OF THE STATE OF NEW YORK WITHOUT GIVING EFFECT TO ANY CONFLICT OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION (BUT GIVING EFFECT TO FEDERAL LAWS RELATING TO NATIONAL BANKS).
