TRADEMARK ASSIGNMENT *NUNC PRO TUNC*

Assignor further assigns to Assignee *Nunc Pro Tunc* effective December 19, 2018 all rights to sue for and receive all damages occurring from past infringing uses of the Marks.

Assignor agrees that upon request by Assignee, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this *Nunc Pro Tunc* Assignment as well as provide such other material, information, or assistance as Assignee may consider reasonably necessary including, but not limited to, providing evidence of Assignee's past and/or present common law use of the Marks.

This Assignment shall be binding on the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith whether in existence as of the effective date of this Assignment or at any time in the future.
