THIS GRANT is made to secure the satisfactory performance and payment of all the Secured Obligations, as such term is defined in the Pledge and Security Agreement among the Grantor, and others, and the Grantee, dated as of January 21, 2019 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"). The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

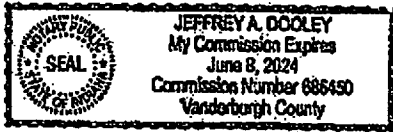

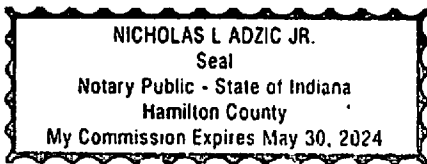
