**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST**

RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST dated as of May 3, 2019 (this "***IP Security Release***"), by JPMORGAN CHASE BANK, N.A. (the "***Collateral Agent***") in favor of the entities listed on Schedules A, B and C hereto (the "***Grantors***"). Reference is made to (a) that certain Intellectual Property Security Agreement dated as of March 31, 2014 (the "***Security Agreement***") among Sungard Availability Services Capital, Inc., the affiliates of Sungard Availability Services Capital, Inc. from time to time party thereto and the Collateral Agent, (b) that certain Patent Security Agreement dated as of August 3, 2015 (the "***2015 Patent Security Agreement***"), between Sungard Availability Services, LP and the Collateral Agent, (c) that certain Copyright Security Agreement dated as of February 25, 2019 (the "***2019 Copyright Security Agreement***"), between Sungard Availability Services, LP and the Collateral Agent, (d) that certain Patent Security Agreement dated as of February 25, 2019 (the "***2019 Patent Security Agreement***"), between Sungard Availability Services, LP and the Collateral Agent, and (e) that certain Trademark Security Agreement Supplement dated as of February 25, 2019 (the "***2019 Trademark Security Agreement***"), between Sungard Availability Services Capital, Inc. and the Collateral Agent (together with the Security Agreement, the 2015 Patent Security Agreement, the 2019 Copyright Security Agreement and the 2019 Patent Security Agreement, the "***Security Documents***").

WHEREAS, pursuant to the terms and conditions of the Security Documents, each Grantor granted to the Collateral Agent a security interest in and to all of such Grantor's right, title and interest in or to any and all Collateral (as such term is defined in the Security Agreement), Patent Collateral (as such term is defined in each of the 2015 Patent Security Agreement and the 2019 Patent Security Agreement), Trademark Collateral (as such term is defined in the 2019 Trademark Security Agreement), and Copyright Collateral (as such term is defined in the 2019 Copyright Security Agreement) (collectively, the "***Released IP Collateral***"), including the following:

- (a) the copyright registrations and applications set forth on Schedule A hereto (the "***Copyrights***");
- (b) the patents and patent applications set forth on Schedule B hereto (the "***Patents***");
- (c) the trademark and service mark registrations and applications set forth on Schedule C hereto (the "***Trademarks***"); and
- (d) all Proceeds (as such term is defined in the Security Agreement) and products of any and all of the foregoing and all collateral security and guarantees given by any Person with respect to any of the foregoing.

WHEREAS, the security interest in the Released IP Collateral was recorded with

the United States Copyright Office on April 11, 2014 at Volume/Document No. 3624/068 and on February 27, 2019 at Volume/Document No. 9960/965 and with the United States Patent and Trademark Office on April 11, 2014 at Reel/Frame No. 32652/864, on April 16, 2014 at Reel/Frame No. 5262/106, on August 3, 2015 at Reel/Frame No. 36254/991, on February 28, 2019 at Reel/Frame No. 48464/646 and on February 28, 2019 at Reel/Frame No. 6576/694.

WHEREAS, Collateral Agent now desires to execute and deliver this IP Security Release to evidence the release of its lien on and security interest in and to the Released IP Collateral identified in Schedules A, B, and C attached hereto on the terms and subject to the conditions hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent and the Grantors hereby agree as follows:

SECTION 1. Release of Security Interest. The Collateral Agent discharges and releases and conveys to the Grantors, without recourse, representation or warranty of any kind, all of the Collateral Agent's security interest in, and right, title and interest in and to, each Grantor's right, title and interest in and to the Released IP Collateral.

SECTION 2. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 3. Miscellaneous. The Collateral Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to make filings with the United States Patent and Trademark Office and the United States Copyright Office and other necessary filings, in each case at the expense of the Grantors, to evidence the release and termination of the Collateral Agent's security interests in the Released IP Collateral.
