TRADEMARK SECURITY AGREEMENT, dated as of May 1, 2019 (this “Agreement”), by and among Jarden Zinc Products, LLC, an Indiana limited liability company, Lifoam Industries, LLC, a Delaware limited liability company, Shakespeare Company, LLC, a Delaware limited liability company, Alltrista Plastics, LLC, an Indiana limited liability company, Hearthmark, LLC, a Delaware limited liability company and Better Heads, L.L.C., a Texas limited liability company (collectively, the “Grantors” and, each, a “Grantor”), and Credit Suisse AG, Cayman Islands Branch as collateral agent (in such capacity, the “Collateral Agent”).

Reference is made to that certain First Lien Credit Agreement, dated as of May 1, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among Parent Holdings, Holdings, the Co-Borrowers, the Lenders from time to time party thereto, Credit Suisse AG, Cayman Islands Branch as Administrative Agent and as Collateral Agent thereunder, the Lenders party thereto and the various other parties thereto and (b) that certain Collateral Agreement, dated as of May 1, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), by and among the Holdings Companies, the Co-Borrowers, the other Grantors from time to time party thereto and the Collateral Agent. The Lenders have agreed to extend credit to the Co-Borrowers subject to the terms and conditions set forth in the Credit Agreement, including in reliance on the Guarantee Agreement. The Grantors are Affiliates of the Co-Borrowers and are willing to execute and deliver this Agreement in order to induce the Lenders to make additional Loans and as consideration for Loans previously made. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Collateral Agreement or the Credit Agreement, as applicable. The rules of construction specified in Section 1.01(b) of the Collateral Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantors, pursuant to and in accordance with the Collateral Agreement, have and hereby do grant to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under any Trademarks now owned or at any time hereafter acquired by such Grantor, or in which such Grantor now has or at any time in the future may acquire any right, title or interest, including those listed on Schedule I (the “Trademark Collateral”); provided that the Trademark Collateral shall not include, and in no event shall the Security Interest attach to, any intent-to-use trademark application prior to the filing of a “Statement of Use” or “Amendment to Allege Use” with respect thereto.


SECTION 3. Collateral Agreement. The Security Interest granted to the Collateral Agent herein is granted in furtherance, and not in limitation, of the security interests granted to the Collateral Agent pursuant to the Collateral Agreement. The Grantors hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.

SECTION 4. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Agreement.
