RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST, dated as of May 15, 2019 (this "Release"), is made by BOKF, NA, in its capacity as collateral agent (the "Releasor"), in favor of MOMENTIVE PERFORMANCE MATERIALS INC. ("Momentive").

WHEREAS, pursuant to and as set forth in the document recorded with the United States Patent and Trademark Office on October 27, 2014 in Reel 5388, Frame 457 (the "Trademark Security Agreement"), Momentive pledged to The Bank of New York Mellon Trust Company, N.A. (the "Former Collateral Agent"), its successors and permitted assigns, a security interest (referred to in this Release as the "Security Interest") in all right, title and interest in or to any and all of the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, pursuant to and as set forth in the document recorded with the United States Patent and Trademark Office on March 6, 2015 in Reel 5473, Frame 0001 (the "Collateral Assignment"), (i) the Former Collateral Agent resigned as collateral agent under the Trademark Security Agreement and Releasor was appointed successor collateral agent thereunder, and (ii) the Security Interest was assigned and transferred to Releasor in its capacity as successor collateral agent under the Trademark Security Agreement.

WHEREAS, Releasor has agreed to terminate and release all of its right, title and interest in or to all such Trademark Collateral, including the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Releasor, hereby (i) terminates, extinguishes, cancels, releases and discharges its Security Interest and all of its right, title and interest in or to the Trademark Collateral, whether granted pursuant to the Trademark Security Agreement, the Collateral Assignment or any other agreement or document delivered in connection with the Trademark Security Agreement or the Collateral Assignment, (ii) terminates the Trademark Security Agreement, the Collateral Assignment and any other agreement or document delivered in connection with the Trademark Security Agreement and the Collateral Assignment with respect to the Trademark Collateral and (iii) reassigns to Momentive any and all right, title and interest (if any) that the Releasor may have in or to any of the Trademark Collateral.


2. Authorization to Record. The Releasor authorizes the United States Patent and Trademark Office and any applicable government officer record this Release.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.
