**TERMINATION OF MEMORANDUM OF SECURITY INTEREST IN

This TERMINATION OF MEMORANDUM OF SECURITY INTEREST IN TRADEMARKS AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of June 3, 2019, is made by and among Bank of America, N.A., as administrative agent ("Administrative Agent"), in favor of ADS Security, a Pennsylvania limited partnership (the "Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to that certain Memorandum of Security Interest in Trademarks dated as of July 1, 2011 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on July 7, 2011 at Reel/Frame No. 004577/0291, the Grantor granted the Administrative Agent a lien on and continuing security interest in ("Lien"), all of its right, title and interest in and to the "Trademarks" (as defined therein) which are set forth on Schedule A attached hereto and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks; and

WHEREAS, the Grantor has requested that the Administrative Agent release its Lien on and continuing security interest in, all right, title and interest of the Administrative Agent in and to the Trademarks.

NOW, THEREFORE, the Administrative Agent, at the Grantor's sole cost and expense, hereby terminates, cancels and releases its Lien on and continuing security interest in and to the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and any and all right, title and interest of the Administrative Agent in the Trademarks shall hereby terminate, cease and become void.
