TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of June 21, 2019, and made by **CITIZENS BANK, N.A.**, successor by merger with Citizens Bank of Pennsylvania (the "Grantee"), to **ANEXINET CORP.**, a Pennsylvania corporation (the "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of October 24, 2014, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on July 24, 2017 at Reel/Frame 6111/0752;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. All capitalized terms used herein and not otherwise defined shall have the meanings ascribed to them in the Security Agreement.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges the Security Interest in and upon the Copyrights, the Patents and the Trademarks listed on Exhibit A hereto.
