RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, Qumpus, Inc., a Georgia corporation with a place of business at 11560 Great Oaks Way, Alpharetta, Georgia 30022 (“Qumpus”) has adopted and used and is the sole and exclusive owner of the trademarks and the registrations therefore listed on Exhibit A hereto and of the goodwill of the business appurtenant thereto (collectively, the “Marks”);

WHEREAS, Atmedia Investor LLC, a Delaware limited liability company with a place of business at 500 7th Ave., 8th Fl. New York, NY 10018, is the holder of a Trademark Security Agreement, dated April 15, 2016, and recorded in the United States Patent and Trademark Office on April 21, 2017, at microfilm Reel No. 6040, Frame No. 0493 (the “Security Interest”), whereby Qumpus granted Atmedia Investor LLC as agent for the benefit of itself and certain lenders (collectively, “Atmedia”) a continuing security interest in certain of Qumpus’s assets, including Qumpus’s trademarks, service marks, trade names, trade dress, logos, designs and other indicators of source of origin, as well as any registration and application for registration of any of the foregoing, and all renewals thereof, including, without limitation, the Marks (collectively, the “Collateral”);

WHEREAS, Atmedia desires to terminate and release the Security Interest in the Collateral in favor of Qumpus;

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Atmedia hereby relinquishes, releases, and discharges the continuing Security Interest in and lien on the Collateral, and assigns, grants, and conveys to Qumpus, any and all rights, title and interest Atmedia may have in or to the Collateral, as well as the goodwill related to the Collateral, and

the right to sue and to recover damages or other appropriate relief for past infringement of the Collateral.

Atmedia hereby represents and warrants that it has not assigned any interest in the Collateral and has the unqualified right to enter into this release and perform its terms.


