**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “**Release**”) is granted on this 26th day of July, 2019, by BANK OF AMERICA, N.A. (“**Bank of America**”), as administrative agent for the lenders under the security agreement referenced below, in favor of CROSSMARK, INC. (the “**Grantor**”).

W I T N E S S E T H :

WHEREAS, on December 21, 2012, Bank of America and Grantor entered into a Trademark Security Agreement, which was recorded with the U.S. Patent and Trademark Office (the “**USPTO**”) on December 26, 2012, at Reel/Frame 4928/0811 (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to the Trademark Security Agreement, Bank of America received security interests in all of Grantor’s rights, titles and interests in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademark registrations and applications for trademark registrations set forth on Schedule A hereto (collectively, the “**Trademarks**”); and

WHEREAS, Bank of America desires to release any and all security interests, and any other lien, it has in the Trademarks, and assign all right, title and interest it may have in and to the Trademarks to Grantor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America hereby agrees as follows:

1. Bank of America hereby absolutely, unconditionally and irrevocably releases, terminates and forever discharges each security interest in the Trademarks that was granted to Bank of America under the Trademark Security Agreement, and any and all other security interests or liens that Bank of America or its predecessors, successors and assigns may have in or to the Trademarks under the Trademark Security Agreement.
2. Bank of America acknowledges and agrees that the Trademark Security Agreement has been terminated.
3. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademarks. Bank of America agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Release.

4. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademarks, Bank of America will execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
5. This Release shall be governed by and construed in accordance with the law of the State of New York.
6. This Release shall be binding upon Bank of America's representatives, successors, assigns and transferees.
