**RELEASE OF SECURITY INTEREST IN UNITED STATES INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES INTELLECTUAL PROPERTY (this "Release"), dated as of July 26, 2019, is made by JPMORGAN CHASE BANK, N.A., as Collateral Agent for the Lenders (the "Collateral Agent") in favor of Western Sales, L.L.C., an Iowa limited liability company ("Western Sales") and Iowa Turkey Growers Cooperative, an Iowa cooperative association ("Iowa Turkey"), and together with Western Sales, each, a "Grantor" and collectively, the "Grantors"). Capitalized terms used but not defined herein shall have the meanings given to them in the Loan Agreement or the Trademark Security Agreement referenced below.

WHEREAS, the Grantors, West Liberty Foods, L.L.C., Protein Processing, L.L.C., the Collateral Agent and certain lenders party thereto entered into that certain Second Amended and Restated Loan and Security Agreement, dated as of September 29, 2006 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Prior Loan Agreement");

WHEREAS, the Prior Loan Agreement has been amended and restated pursuant to certain subsequent agreements, including that certain Sixth Amended and Restated Credit Agreement, dated as of October 12, 2018, by and among the Grantors, Liberty Free Range Purveyor, L.L.C. and Liberty Free Range Poultry, L.L.C., as borrowers, the lenders party thereto and JPMorgan Chase Bank, N.A., as Administrative Agent for the lenders;

WHEREAS, in connection with the Prior Loan Agreement, the Grantors and the Collateral Agent entered into that certain Second Amended and Restated Trademark Security Agreement, dated as of September 29, 2006 (the "Trademark Security Agreement") for purposes of filing with the United States Patent and Trademark Office ("USPTO");

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor granted to the Collateral Agent on behalf of the Lenders, a continuing security interest in all of such Grantor's right, title and interest in, to and under certain intellectual property collateral, as set forth therein, (the "Trademark Collateral"), including, without limitation, all of the trademarks listed on Schedule I;

WHEREAS, the Trademark Security Agreement was recorded in the USPTO on October 10, 2006 at Reel/Frame 3404/0775;

WHEREAS, the Grantors have requested that the Collateral Agent release and reassign its interest in the Trademark Collateral; and

WHEREAS, the Collateral Agent desires to confirm its release of its rights and security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement and terminates, releases and discharges any security interest in and lien upon the Trademark Collateral, and assigns, transfers, and conveys to the Grantors any and all right, title or interest in, or to, the Trademark Collateral the Collateral Agent may hold.

Collateral Agent agrees, at the Grantors' expense, to take all further actions, and provide to each Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as each Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
