RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of this 16th day of August, 2019, is entered into by and between Bank of America, N.A., a national banking association, in its capacity as Grantee ("Grantee") under the Security Agreements (as defined below), and R.A.B. Food Group, LLC, a Delaware limited liability company with its principal place of business at 80 Avenue K, Newark, New Jersey 07105-3803 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain (i) Omnibus Pledge and Security Agreement, dated as of February 22, 2007 (the "Pledge Agreement"), by and among Grantor and JPMorgan Chase Bank, N.A., as administrative agent for certain secured parties, as grantee ("JPM Grantee") and (ii) Security Agreement (Trademarks), dated as of February 22, 2007, (the "February Security Agreement"), Grantor granted to and in favor of JPM Grantee a security interest in and to all of Grantor's right, title and interest in, to and under the trademarks, and registrations of and applications to register the foregoing, owned by Grantor, including, without limitation, certain of the trademarks listed on Schedule A attached hereto (collectively, the "February Trademarks"), in each case, together with the proceeds of any and all of the foregoing;

WHEREAS, the February Security Agreement was recorded with the United States Patent and Trademark Office on February 23, 2007, at Reel 3486, Frame 0898;

WHEREAS, pursuant to that certain Assignment of Grant of Security Interest, dated as of August 14, 2007 (the "Assignment Agreement") by and between JPM Grantee and Grantee, JPM Grantee granted and assigned to and in favor of Grantee all of its right, title and interest in, to and under the 2007 Trademarks;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office on August 14, 2007, at Reel 3601, Frame 0347;

WHEREAS, pursuant to the terms and conditions of that certain (i) Amended and Restated Omnibus Pledge and Security Agreement, dated as of August 14, 2007 (the "Amended Pledge Agreement"), by and among Grantor, the other pledgors party thereto and Grantee and (ii) Security Agreement (Trademarks), dated as of August 14, 2007, (the "August Security Agreement," and together with the Pledge Agreement, February Security Agreement, Assignment Agreement, and Amended Pledge Agreement, collectively, the "Security Agreements"), Grantor granted to and in favor of Grantee a security interest in and to all of Grantor's right, title and interest in, to and under certain of the trademarks listed on Schedule A attached hereto (collectively, the "August Trademarks"), and together with the February Trademarks, collectively, the "Trademarks");

WHEREAS, the August Security Agreement was recorded with the United States Patent and Trademark Office on August 14, 2007, at Reel 3601, Frame 0379;

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Grantee, without recourse, representation or warranty, absolutely and unconditionally terminates, cancels, discharges and releases any and all security interests it has against the Trademarks pursuant to any of the Security Agreements or otherwise.


Grantee agrees to take all further actions, and provide to Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor, at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

Grantee expressly acknowledges and affirms that upon execution and delivery hereof to Grantor, it shall have no rights and remedies with respect to the Trademarks.
