## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of February 8, 2019 in favor of SCT Holdings, LLC, a Delaware limited liability company ("Holdings"), Stancor Holdings, LLC, a Delaware limited liability company ("Parent"), and Stancor, L.P., a Delaware limited partnership ("Borrower"; Holdings, Parent and Borrower are referred to herein, collectively, as "Grantors" and, individually, as a "Grantor"), by TCF National Bank, in its capacity as administrative agent (in such capacity, the "Administrative Agent") for the lenders from time to time party to the Credit Agreement referred to in the Security Agreement (as defined below).

WHEREAS, pursuant to the terms and conditions of that certain Patent, Copyright and Trademark Security Agreement, dated as of August 8, 2018 (the "Security Agreement") executed by Grantors in favor of the Administrative Agent, each Grantor granted to the Administrative Agent a security interest in all of such Grantor's right, title and interest in and to the trademark applications and registrations set forth on Schedule 1 attached hereto (collectively the "Trademarks");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on August 8, 2018 at Reel/Frame 6407/0622.

WHEREAS, the Administrative Agent wishes to release its security interest in the Trademarks and reassign to each Grantor all of the Administrative Agent's right, title and interest in and to the Trademarks of such Grantor.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates the Security Agreement, and hereby terminates, cancels and releases any security interest it may have in the Trademarks and reassigns to each Grantor any rights it may have in the Trademarks.

The Administrative Agent shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release. Each Grantor is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
