**JOINDER AND THIRD AMENDMENT AND SUPPLEMENT TO
SECOND AMENDED AND RESTATED
TRADEMARK SECURITY AGREEMENT**

This Joinder and Third Amendment and Supplement to Second Amended and Restated Trademark Security Agreement, dated as of _____ July 31, 2019 (this "Agreement"), is made by and among **PACKERS ACQUISITION CO.**, a Florida corporation ("Packers"), **AMALIE OIL COMPANY**, a Florida corporation formerly known as Petroleum Packers, Inc. ("Amalie"), **PETROLEUM PACKERS OF JACKSONVILLE II, INC.**, a Florida corporation ("Jacksonville II"; together with Packers and Amalie, each, an "Existing Borrower" and, collectively, "Existing Borrowers"), **AOCLSC, INC.**, a Florida corporation ("New Borrower", and together with the Existing Borrowers, each a "Borrower" and collectively, "Borrowers"), **AOC OIL, INC.**, a Florida corporation formerly known as Petroleum Packers of Jacksonville, Inc. ("Petroleum"), **AMALIE AOC, LTD.**, a Florida limited partnership ("Amalie AOC"), and **AC OIL CORP.**, a Florida corporation ("AC Oil"; together with Existing Borrowers, New Borrower, Petroleum, and Amalie AOC, each individually, a "Company" and collectively, "Companies"), each having its principal place of business at 1601 McCloskey Boulevard, Tampa, Florida 33605-6710, and **BANK OF AMERICA, N.A.**, a national banking association having an office at 300 Galleria Parkway, Suite 800, Atlanta, Georgia 30339 (together with its successors and assigns, "Lender").

Recitals

Existing Borrowers and Lender are parties to that certain Amended and Restated Loan and Security Agreement, dated as of December 27, 2018 (as amended, restated, modified or supplemented from time to time, the "Loan Agreement"), setting forth the terms on which Lender may now or hereafter extend credit to or for the account of Existing Borrowers.

Existing Borrowers, Petroleum, Amalie AOC, AC Oil and Lender entered into that certain Second Amended and Restated Trademark Security Agreement, dated as of January 31, 2013 (as amended, restated supplemented or otherwise modified from time to time, including most recently by that certain Second Amendment and Supplement to Second Amended and Restated Trademark Security Agreement, dated as of December 27, 2018, the "Trademark Agreement"), as security for the Obligations owing under the Loan Agreement.

Existing Borrowers, New Borrower, Petroleum, Amalie AOC, AC Oil and Lender are now entering into that certain Joinder Agreement and First Amendment to Amended and Restated Loan and Security Agreement and Other Loan Documents, and Waiver dated as of the date hereof (the "First Amendment"), which provides for, among other things, the joinder of New Borrower as a Borrower under the Loan Agreement, and certain other amendments, modifications, supplements and waivers under the Loan Agreement.

As a condition to the effectiveness of the First Amendment and the joinder of New Borrower as described therein, Lender has required the execution and delivery of this Agreement by Companies, whereby New Borrower shall grant Lender a security interest in the Trademarks described herein.

ACCORDINGLY, in consideration of the mutual covenants contained in the Loan Documents and herein, the parties hereby agree as follows:

1. Definitions. All terms defined herein without definition shall have the meanings ascribed to such terms in the Trademark Agreement.

2. Joinder of New Borrower. By its signature below, New Borrower becomes a "Company" under (and as defined in) the Trademark Agreement with the same force and effect as if originally named therein as a Company thereunder, and New Borrower hereby assumes, and hereby agrees to perform and observe, each and every one of the terms and provisions of the Trademark Agreement applicable to it as a Company thereunder. Each reference to "Company," "Companies" or terms of similar import in the Trademark Agreement shall be deemed to include New Borrower. New Borrower shall be directly and primarily liable as a Company for all of the representations, warranties, covenants and other obligations now or hereafter owing under the Trademark Agreement, and New Borrower hereby confirms that it has assumed all such obligations.

3. Supplement to Trademark Agreement. The Trademark Agreement is hereby further amended and supplemented by adding the Trademarks listed on Schedule 1 to this Agreement to Exhibit A of the Trademark Agreement.

4. Security Interest. New Borrower hereby irrevocably pledges and assigns to, and grants to Lender a security interest (the "Security Interest"), with power of sale to the extent permitted by law, in the Trademarks to secure payment of the Obligations. As set forth in the Loan Agreement and the other Loan Documents, the Security Interest is coupled with a security interest in substantially all of the personal property of New Borrower.

5. Acknowledgment. Each assignment, grant of security interest and other rights provided to Lender, together with all obligations, covenants and liabilities of, the Companies in the Trademark Agreement are hereby reaffirmed. This Agreement has been executed and delivered by the Companies for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to Lender in connection with the Loan Agreement and the Trademark Agreement and is expressly subject to the terms and conditions thereof. The Trademark Agreement (and all rights and remedies of Lender thereunder) shall remain in full force and effect in accordance with its terms.



This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually executed counterpart of this Agreement.

THE PARTIES WAIVE ANY RIGHT TO TRIAL BY JURY IN ANY ACTION OR PROCEEDING BASED ON OR PERTAINING TO THIS AGREEMENT.


