TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment"), effective as of October 1, 2013 ("Effective Date"), is entered into by and between CONOPCO, INC., a New York corporation ("Assignor") and PINNACLE FOODS GROUP LLC, a Delaware limited liability company ("Assignee"). Assignor and Assignee are sometimes referred to herein individually as a "Party" and collectively as the "Parties."

WHEREAS, Assignor owns the trademarks and trademark applications listed in the attached Schedule A, together with the goodwill related to Assignor's business associated therewith (the "Trademarks");

WHEREAS, pursuant to, and upon the terms of, that certain Asset Purchase Agreement (the "Asset Purchase Agreement"), dated as of August 11, 2013, between Assignor and Pinnacle Foods Inc., a Delaware corporation ("Parent"), Assignee desires to acquire the Trademarks, and Assignor desires to assign its rights in the Trademarks to Assignee;

WHEREAS, Assignee is a wholly owned subsidiary of Parent, and, pursuant to Section 11.01 of the Asset Purchase Agreement, and that certain Assignment and Assumption Agreement, dated as of September 25, 2013 (the "A&A Agreement"), among Parent, Assignee and Pinnacle Foods Canada Corporation, an Ontario, Canada corporation, Parent has assigned to Assignee its right to purchase all of the Transferred Intellectual Property, Additional Trademarks, and Transferred Technology under the Asset Purchase Agreement; and

WHEREAS, the execution and delivery of this Assignment is a delivery requirement for Assignor pursuant to Section 2.02(a)(ii) of the Asset Purchase Agreement.

NOW, THEREFORE, for the consideration stated in the Asset Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, pursuant to the General Intellectual Property Assignment between Assignor and Assignee, dated October 1, 2013, Assignor has assigned, transferred and conveyed unto Assignee, and assigns to Assignee all of Assignor's right, title, and interest in and to, the Trademarks, and the portion of Assignor's business to which the Trademarks pertain and any and all rights to sue and recover and retain damages for any current, past or future infringement thereof.

This Assignment shall be binding upon, and shall inure to the benefit of, the Parties hereto and their respective successors and assigns, and may be executed in two or more counterparts, each of which shall be deemed an original, and it shall not be necessary in making proof of this Assignment to produce or account for more than one set of counterparts signed by all of the Parties.

No waiver, modification, or change of any of the provisions of this Assignment shall be valid unless in writing and signed by the Party against whom such claimed waiver, modification, or change is sought to be enforced.
