RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby:

1. fully and irrevocably releases, terminates and discharges, and reassigns to Grantor, any and all liens, security interest, right, title and interest of Lender pursuant to the Patent and Trademark Security Agreement in, to and under the Patents and Trademarks, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to Lender pursuant to or in connection with the Patent and Trademark Security Agreement is terminated; and
3. authorizes and requests that this Release of Security Interest in Patents and Trademarks be recorded at the USPTO.
