Re: Payoff Letter - Relating to Term Loan Agreement between Triumph Group, Inc. ("TGI"), each of the lenders thereunder (the "Term Lenders") and Royal Bank of Canada, as administrative agent and collateral agent for Term Lenders (the "Term Agent"), dated as of June 16, 2010 (the "Term Loan Agreement")

Ladies and Gentlemen:

We understand that TGI and the Guarantors (as defined in the Term Loan Agreement) intend to enter into an amended and restated credit facility with the lenders under that credit agreement among TGI, the other borrowers and guarantors thereunder, the banks thereunder (the "New Lenders") and PNC Bank, National Association, as administrative agent for the New Lenders (the "New Agent"). TGI owes certain obligations to the Term Lenders pursuant to the Term Loan Agreement. Immediately upon the closing of the new credit facility with the New Lenders and the New Agent (the "Closing") and receipt of the Payoff Amount (as defined below) by the Term Agent, the Intercreditor Agreement (as defined in the Term Loan Agreement), the Term Loan Agreement, the Guarantee and Collateral Agreement (as defined in the Term Loan Agreement) and the other Loan Documents (as defined in the Term Loan Agreement) and all commitments of the Term Lenders under the Term Loan Agreement and the other Loan Documents shall terminate, and all obligations of (i) TGI under the Term Loan Agreement and under the other Loan Documents and (ii) the Guarantors under the Guarantee and Collateral Agreement and the other Loan Documents shall in each case be satisfied, terminated and released.

Upon receipt by the Term Agent of the Payoff Amount, in good funds, the Term Agent hereby agrees that all liens and security interests granted by TGI and the Guarantors in favor of the Term Agent or the Term Lenders shall, without any further action by the Term Agent, the Term Lenders, the New Agent, the New Lenders, TGI or any Guarantor, be irrevocably and unconditionally terminated and released in full, and each of TGI, each Guarantor and the New Agent, as TGI's and each Guarantor's designee, or such other designee as TGI or any Guarantor may nominate (together with the New Agent, each a "TGI Designee"), is hereby authorized to file or record in any jurisdiction such termination statements, mortgage and/or deed of trust satisfaction pieces and other documents relating to liens and security interests granted by TGI or any Guarantor in any collateral in favor of the Term Agent or the Term Lenders as TGI, any Guarantor or any TGI Designee deems appropriate to evidence such release and termination. In furtherance thereof, the Term Agent agrees, subsequent to the Closing, to (i) execute such

termination statements, mortgage and/or deed of trust satisfaction pieces and other documents relating to liens and security interests granted by TGI or any Guarantor in favor of the Term Agent or the Term Lenders as TGI, any Guarantor or any TGI Designee may reasonably request and (ii) cause any stock certificates, other instruments and any other possessory collateral which represent collateral released hereunder to be delivered to New Agent.

For purposes hereof the term "Payoff Amount" shall mean the aggregate amount set forth under the "Total" column set forth below, which amount is effective as of April 5, 2011, plus interest after such date at a per diem of \$49,964.90.


