This NOTICE OF SUCCESSION OF AGENCY (this "Notice"), dated as of October 31, 2019 (the "Effective Date"), is executed by Deutsche Bank AG New York Branch, in its capacity as Administrative Agent under the Original Agreements (as defined below) (the "Prior Agent"), and Bank of America, N.A., in its capacity as Administrative Agent under the Amended and Restated Credit Agreement and Security Agreement (as defined below) (the "Successor Agent").

WHEREAS, pursuant to that certain Credit Agreement, dated as of April 16, 2013, by and among ABC Supply Holding Corp., a Delaware corporation ("Holdings"), American Builders & Contractors Supply Co., Inc., a Delaware corporation (the "Borrower"), Deutsche Bank Trust Company Americas, in its capacity as administrative agent (the "Initial Agent"), and certain other parties thereto (as amended and restated by that certain Restatement Agreement, dated as of October 31, 2016, by and among Holdings, the Borrower, the Initial Agent, the Prior Agent and certain other parties thereto, and as further amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Existing Credit Agreement"), (i) the Initial Agent and certain grantor parties identified on the signature pages thereto (the "Grantors") entered into that certain Security Agreement, dated as of April 16, 2013, as amended and restated on October 31, 2016 (the "Security Agreement"), (ii) the Initial Agent and the Grantors entered into the Trademark Security Agreement, dated as of April 16, 2013 (the "First Trademark Security Agreement"), (iii) the Initial Agent and the Grantors entered into the Trademark Security Agreement, dated as of November 17, 2015 (the "Second Trademark Security Agreement"), (iv) the Initial Agent, the Prior Agent and the Grantors entered into that certain Resignation and Assignment Agreement, dated as of October 31, 2016, that certain Notice of Succession of Agency for Trademarks, dated as of October 31, 2016 (the "First Agency Transfer for Trademarks"), and that certain Notice of Succession of Agency for Trademarks, dated as of October 29, 2019 (the "Second Agency Transfer for Trademarks"), whereby the Initial Agent resigned as Administrative Agent and was succeeded to and replaced by the Prior Agent as successor Administrative Agent, (v) the Prior Agent and the Grantors entered into the Trademark Security Agreement, dated as of October 31, 2016 (the "Third Trademark Security Agreement"), and (vi) the Prior Agent and the Grantors entered into the Trademark Security Agreement, dated as of June 25, 2018 (the "Fourth Trademark Security Agreement"), in each case, pursuant to which the Grantors granted a security interest in and to certain collateral;

WHEREAS, (i) the First Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 16, 2013 at Reel/Frame 5007/0805, (ii) the Second Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 19, 2015 at Reel/Frame 5673/0137, (iii) the Agency Transfer for Trademarks was recorded with the United States Patent and Trademark Office on November 4, 2016 at Reel/Frame 5919/0770, (iv) the Third Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 4, 2016 at Reel/Frame 5914/0313, (v) the Fourth Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 19, 2018 at Reel/Frame 6385/0356 and (vi) the Second Agency Transfer for Trademarks is pending recordation with the United States Patent and Trademark Office, in each case, with respect to the trademarks identified on Schedule A attached hereto;

WHEREAS, the Existing Credit Agreement was amended and restated, as of October 31, 2019 (as amended and restated, the "Amended and Restated Credit Agreement"), and in connection with the transactions under the Amended and Restated Credit Agreement, the Prior Agent, the Successor Agent,

Borrower and certain other parties have entered into that certain Resignation and Assignment Agreement, dated as of October 31, 2019 (the "Resignation Agreement"), whereby the Prior Agent resigned as Administrative Agent and is succeeded to and replaced by the Successor Agent as successor Administrative Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Resignation Agreement.

2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Resignation Agreement, the Prior Agent has ceased to be Administrative Agent under such capacity and is succeeded to and replaced by the Successor Agent as Administrative Agent under such capacity. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Agent under the First Trademark Security Agreement, the Second Trademark Security Agreement, the Third Trademark Security Agreement or the Fourth Trademark Security Agreement, which security interest is now succeeded by and transferred to the Successor Agent.
