Assignor, for itself, and its heirs, assigns, and legal representatives hereby further covenants to and with Assignee, its assigns, successors, and legal representatives to fully cooperate therewith in perfecting this assignment in the United States and in any and all foreign jurisdictions, said cooperation extending to the Mark and the Registration, and including the execution of additional assignments or other formal documents as may be required in connection therewith.

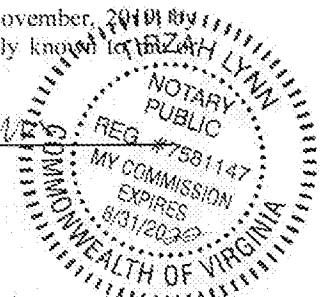
