1. I hold the position of Vice President, Corporate Counsel & Assistant Secretary of Scientific Games International, Inc. I have direct knowledge of the information set out below.
2. Scientific Games International, Inc. is the current owner of the following trademark registrations (the "Gem|Intelligence Marks"):

3. At the time of registration of the Gem|Intelligence Marks set out in paragraph 2 above, Lapis Software Associates LLC, a New Jersey limited liability company, was the owner of the Gem|Intelligence Marks.

On March 3, 2017, Scientific Games International, Inc. acquired complete ownership and control over Lapis Software Associates, LLC by entering into and executing a Membership Interest Purchase and Sale Agreement with the previous member owners of Lapis Software Associates, LLC, namely, Jean Lombard, Edward M. Pease, and Adam Shapiro.
5. On September 30, 2019, Lapis Software Associates, LLC was terminated and dissolved as an entity with the New Jersey Secretary of State. Attached as Exhibit "A" to my Affidavit is the email confirmation from the New Jersey Secretary of State dated September 30, 2019 confirming the dissolution and termination of Lapis Software Associates, LLC as filed and paid for by Scientific Games International, Inc.

6. As a result of the termination and dissolution of Lapis Software Associates, LLC, all of the assets of Lapis Software Associates, LLC, including the Gem[Intelligence Marks, were transferred by operation of law to Scientific Games International, Inc.

7. I confirm that Scientific Games International, Inc. is a legal entity and the correct owner of the Gem[Intelligence Marks listed in paragraph 2 above.




