**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks ("Trademark Release") is made as of December 12, 2019, by **REGIONS BANK**, an Alabama banking corporation ("Collateral Agent") in favor of **TIJUANA FLATS RESTAURANTS, LLC**, a Florida limited liability company with an address at 2300 Maitland Center Pkwy., Ste. 306, Maitland, FL 32751 (the "Grantor").

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated July 31, 2015 (the "Trademark Security Agreement") with Agent, notice of which was recorded on August 5, 2015 at the United States Patent and Trademark Office at Reel 5593, Frame 0766.

WHEREAS, Grantor granted the Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the "Security Interest") in favor of the Agent, in and to all of its trademark collateral (the "Trademark Collateral"), including without limitation the Trademarks listed in the Trademark Security Agreement.


WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates, and discharges any and all of its interest in the Trademark Collateral of the Grantor, including and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and assigns, transfers, and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens. The Agent further hereby waives and relinquishes all its rights, powers, privileges, and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities, and warranties in association with the Security Interest.
