TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Trademark Assignment”) is made and entered into as of the 1st day of January, 2018 (the "Effective Date") by and among **TURBINE ENGINE COMPONENTS TECHNOLOGIES CORPORATION** (“Assignor”), a Delaware corporation, having a principal place of business at 1211 Old Albany Road, Thomasville, GA 31792 and **OFFICE SUPPORT SERVICES, LLC** (“Assignee”), a North Carolina limited liability company, having a principal place of business at Two Town Square Boulevard Suite 310, Asheville, NC 28803. Assignor and Assignee may be referred to herein individually as a “Party” and collectively as the “Parties.”

WHEREAS, Assignor is the owner of all right, title, and interest in the United States and foreign trademarks listed in Exhibit A (the “Trademarks”);

WHEREAS, Assignee desires to acquire such right, title, and interest in the Trademarks for the purposes and pursuant to the terms as set forth herein.

NOW, THEREFORE, the Parties hereto, intending to be legally bound, agree as follows:

1. **Purchase Price**. Assignee agrees to pay Assignor the sum of ten dollars (\$10.00), (“Purchase Price”), the receipt of which is hereby acknowledged, as consideration for the assignment of the Trademarks.
2. **Assignment of Trademarks**. In consideration of the Purchase Price, the exchanges provided for in the Agreement, and for other good and valuable consideration, Assignor, subject to any existing licenses, namely, (1) the license dated December 8, 2017 to UCA HOLDINGS, INC. and (2) the license dated December 8, 2017 to TECT AEROSPACE GROUP HOLDINGS,

INC., does hereby sell, transfer, convey, set over, assign, and deliver to Assignee all worldwide rights, title, and interest in and to the Trademarks, whether statutory or common law, including, without limitation: (1) any and all registrations therefore; (2) the goodwill of the business relating to the products and services on which the Trademarks are used and for which they are registered; (3) common law trademark and service mark rights in the Trademarks; (4) the right to license the Trademarks; and (5) the right to sue and recover therefore, including the right to bring suit in its own name and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and other legal representatives. Upon execution of this Trademark Assignment, Assignor shall retain no right or license under the Trademarks.

3. **Additional Obligations.** Assignor will execute additional documents and, at Assignee's sole cost and expense, take other reasonable actions as may be necessary to secure, record, or perfect the assignment of the Trademarks set forth herein, and to vest in Assignee all right, title, and interest in and to the Trademarks. Assignor hereby authorizes Assignee to record this Trademark Assignment or such further assignment documents as may be required with the United States Patent and Trademark Office or foreign trademark offices or tribunals with respect to the Trademarks.

4. **Jurisdiction and Disputes.** This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule. Any legal suit, action, or proceeding arising out of or based upon this Trademark Assignment, the other transaction documents or the transactions contemplated hereby or thereby may be instituted in the United States District Court for the Delaware and each Party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action, or proceeding. Service of process, summons, notice, or other document by mail

to such Party's address set forth herein shall be effective service of process for any suit, action, or other proceeding brought in any such court. The Parties irrevocably and unconditionally waive any objection to the laying of venue of any suit, action, or any proceeding in such courts and irrevocably waive and agree not to plead or claim in any such court that any such suit, action, or proceeding brought in any such court has been brought in an inconvenient forum.


5. **Miscellaneous.** This Trademark Assignment constitutes the entire understanding of the Parties as to the specific subject matter hereof, revokes and supersedes all prior agreements between the Parties with respect to the Trademarks, and is intended as a final expression of their Trademark Assignment. It shall not be modified or amended except in writing signed by the Parties hereto and specifically referring to this Trademark Assignment. This Trademark Assignment shall take precedence over any other documents which may be in conflict therewith, except that in the event of any conflict between this Trademark Assignment and the Agreement, the terms of the Agreement shall be controlling. This Trademark Assignment shall be binding upon and shall inure to the benefit of the Parties hereto, their heirs, administrators, successors and assigns. If any provision hereof is held invalid or unenforceable by a court of competent jurisdiction, such invalidity shall not affect the validity or operation of any other provision and such invalid provision shall be deemed to be severed from the Trademark Assignment. This Trademark Assignment is the result of arm's length negotiations between the Parties and shall be construed to have been drafted by the Parties such that any ambiguities in this Trademark Assignment shall not be construed against either Party. The section headings contained herein are for convenience in reference and are not intended to define or limit the scope of any provision of this Trademark Assignment.


