**TERMINATION AND RELEASE OF TRADEMARK, PATENT AND COPYRIGHT
COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK, PATENT AND COPYRIGHT COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT (this "Termination"), is dated as of January 2, 2020, and made by **ENTERPRISE BANK & TRUST**, as administrative agent (the "Grantee"), to **CARSTIN BRANDS LLC**, a Delaware limited liability company and **CALLAHAN KITCHEN AND BATH LLC**, a Delaware limited liability company (collectively, the "Grantor").

WHEREAS, pursuant to that certain Trademark, Patent and Copyright Collateral Assignment and Security Agreement dated as of December 30, 2014 by the Grantor in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on February 20, 2015 at Reel/Frame 005463 / 0232; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
