**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of January 23, 2020 by **SILICON VALLEY BANK**, as administrative agent for the Lenders (the “*Bank*”), in favor of **PESTROUTES OPCO, LLC**, a Delaware limited liability company, **PCO CENTRAL, LLC**, a Delaware limited liability company, and **FIELD SERVICE HOLDINGS, LLC**, a Delaware limited liability company (each a “*Grantor*” and, collectively, the “*Grantors*”).

WHEREAS, the Grantors executed and delivered an Intellectual Property Security Agreement, dated as of March 21, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Agreement*”), granting to the Bank a security interest in all of their right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademark and Trademark Applications (“*Trademarks*”), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on March 21, 2019, at Reel 6597, Frame 0409;

WHEREAS, the Grantors have requested that the Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantors in, to and under all of the Trademarks (as defined in the Agreement) as herein provided; and

WHEREAS, the Grantors have requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank’s security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in each Grantor’s right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
