ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Assignment of Intellectual Property Security Agreement (this “**Agreement**”) is effective as of January 31, 2020 by Credit Suisse AG, Cayman Islands Branch (“**Credit Suisse**”), as former collateral agent under the Security Agreement (as defined below), in favor of Cerberus Business Finance, LLC (“**Cerberus**”), as successor collateral agent for the Lenders (as defined in the Security Agreement) now or hereafter party to the Security Agreement. All capitalized terms used but not otherwise defined herein shall have the respective meanings assigned thereto in the Security Agreement.

WITNESSETH:

WHEREAS, Blair LLC, Draper’s & Damon’s LLC, Gold Violin LLC, Haband Company LLC, Johnny Appleseed’s, Inc., Linen Source Acquisition LLC, Norm Thompson Outfitters LLC (f/k/a Norm Thompson Outfitters, Inc.), Orchard Brands Corporation, Wintersilks, LLC, and Bluestem Brands, Inc. (each a “**Grantor**,” collectively, the “**Grantors**”) have entered into that certain Pledge and Security Agreement, dated November 7, 2014, as supplemented by that certain Supplement No. 1, dated July 10, 2015 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the “**Security Agreement**”), in favor of Credit Suisse;

WHEREAS, pursuant to the Security Agreement, each Grantor entered into that certain Intellectual Property Security Agreement, dated as of July 10, 2015 and recorded at Trademark Reel 005579 Frame 0127 of the United States Patent and Trademark Office (the “**IP Security Agreement**”), pursuant to which each Grantor pledged, collaterally assigned, mortgaged, transferred and granted to Credit Suisse, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest in all of its right, title and interest in, to or under all of the following assets, whether then owned or at any time thereafter acquired by or arising in favor of such Grantor and regardless of where located (collectively, the “**IP Collateral**”):

- i) (a) all trademarks (including service marks), common law marks, trade names, trade dress, and logos, slogans and other indicia of origin under the Requirements of Laws of any jurisdiction in the world, and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing, (b) all renewals of the foregoing, (c) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof, (d) all rights to sue for past, present and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing, and (e) all domestic rights corresponding to any of the foregoing (“**Trademarks**”), including the Trademark registrations and registration applications in the United States Patent and Trademark Office listed on Schedule I hereto;
- ii) (a) all copyrights, rights and interests in copyrights, works protectable by copyright whether published or unpublished, copyright registrations and copyright applications, (b) all renewals of any of the foregoing, (c) all income, royalties, damages, and

payments now or hereafter due and/or payable under any of the foregoing, including, without limitation, damages or payments for past or future infringements for any of the foregoing, (d) the right to sue for past present and future infringement of any of the foregoing, and (e) all rights corresponding to any of the foregoing (“**Copyrights**”), including the Copyright registrations and pending applications for registration in the United States Copyright Office and all Exclusive Copyright Licenses, in each case, listed on Schedule II;

- iii) (a) any and all patents and patent applications; (b) all inventions described and claimed therein, (c) all reissues, divisions, continuations, renewals, extensions, and continuations-in-part thereof, (d) all income, royalties, damages, claims and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages and payments for past and future infringements thereof, (e) all rights to sue for past, present and future infringements thereof, and (f) all rights corresponding to any of the foregoing (“**Patents**”); and
- iv) all proceeds of the foregoing; in each case to the extent the foregoing items constitute Collateral.

WHEREAS, pursuant to that certain Successor Agent Agreement (the “**Successor Agreement**”), dated as of January [31], 2020, Credit Suisse resigned as collateral agent under the Security Agreement and irrevocably assigned and delegated to Cerberus all of its rights, authority and powers, as collateral agent under the Security Agreement, and Cerberus was appointed as successor collateral agent and vested with, and succeeded to the rights, authority and powers of the collateral agent under the Security Agreement; and

WHEREAS, pursuant to the Successor Agent Agreement, Credit Suisse transferred to Cerberus all Collateral held under the Security Agreement, including any and all of its interests in the IP Collateral and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof, as applicable, which heretofore had been acquired from each Grantor pursuant to the respective IP Security Agreement, and agreed to execute and deliver to Cerberus, or otherwise authorized the filing of, any amendments to financing statements or similar documents, and agreed to take such other action, as would be necessary or appropriate in connection with the assignment to Cerberus of the security interests created under the Security Agreement.

NOW, THEREFORE, in consideration of the premises and agreements and provisions contained herein, Credit Suisse, as the former collateral agent, acknowledges and agrees that it has assigned and transferred unto Cerberus, as successor collateral agent, and Cerberus, as the successor collateral agent, acknowledges and agrees, that it has succeeded to, all right, title and interest in and to the IP Collateral of each Grantor held by Credit Suisse in its capacity as former collateral agent.

This Agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York, without


giving effect to applicable principles of conflicts of law to the extent that the application of the laws of another jurisdiction would be required thereby.


