**GRANT OF SECURITY INTEREST IN TRADEMARKS**

This **GRANT OF SECURITY INTEREST IN TRADEMARKS** (this "Agreement"), dated as of February 5, 2020, is made by each Subsidiary of **RITE AID CORPORATION**, a Delaware corporation (the "Issuer") listed on Schedule I, Schedule II, Schedule III and Schedule IV hereto (such Subsidiaries, collectively, the "Grantors", and each individually, a "Grantor"), in favor of **THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A. ("BNYMNA")**, in its capacity as the collateral agent for the Notes Secured Parties (as defined in the Subsidiary Security Agreement referred to below) (in such capacity, together with its successors and assigns in such capacity, the "Notes Collateral Agent").

**WHEREAS**, the Issuer, the Grantors and BNYMNA, in its capacity as trustee for the Holders (as defined in the Indenture referred to below) (in such capacity, together with its successors and assigns in such capacity, the "Trustee") have entered into an Indenture, dated as of the date hereof, (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the "Indenture") evidencing the securities issued thereunder and the guarantees thereon;

**WHEREAS**, each Grantor has agreed to guarantee, among other things, all Guaranteed Obligations (under and as defined in the Indenture) pursuant to the terms of the Indenture made by the Grantors in favor of the Notes Collateral Agent, for the benefit of the Notes Secured Parties;

**WHEREAS**, in connection with the Subsidiary Security Agreement, each Grantor has agreed to grant to the Notes Collateral Agent, its successors and assigns, for the ratable benefit of the Notes Secured Parties, a security interest in all right, title or interest now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest in, to and under the Senior Collateral (under and as defined in the Subsidiary Security Agreement ), including in Intellectual Property (as defined in the Subsidiary Security Agreement), to secure their obligations under the Subsidiary Security Agreement and the other Notes Collateral Documents (as defined in the Indenture) pursuant to the terms of the Subsidiary Security Agreement, dated as of February 5, 2020 (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the "Subsidiary Security Agreement") made by the Grantors in favor of the Notes Collateral Agent, for the benefit of the Notes Secured Parties;

**WHEREAS**, pursuant to the terms of the Subsidiary Security Agreement, the Grantors are required to execute this Agreement; and

**WHEREAS**, the Grantors are affiliates of one another, will derive substantial direct and indirect benefits from the execution, delivery and performance of the obligations under the Indenture and the Subsidiary Security Agreement and each is, therefore, willing to enter into this Agreement.

**NOW, THEREFORE**, the Grantors and the Notes Collateral Agent, on behalf of itself and each other Notes Secured Party (and each of their respective successors and assigns), hereby agree as follows:

SECTION 1. **Definitions.** Unless otherwise defined herein, capitalized terms used herein shall have the meanings given to such terms in the Subsidiary Security Agreement and, if not defined therein, in the Indenture.

SECTION 2. **Grant of Security Interest.** As security for the payment and performance, as the case may be, in full of the Notes Obligations, each Grantor hereby assigns and pledges to the Notes Collateral Agent, its successors and assigns, for the ratable benefit of the Notes Secured Parties, and hereby grants to the Notes Collateral Agent, its successors and assigns, for the ratable benefit of the Notes Secured Parties, a security interest in all right, title or interest now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time in the future may acquire any right, title or interest in, to and under (a)(i) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office, including those identified on Schedule A hereto, or in any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, (ii) all goodwill associated therewith or symbolized thereby and (iii) all other assets, rights and interests that uniquely reflect or embody such goodwill (collectively, the "Trademarks"), (b) any written agreement to which any Grantor is a party, now or hereafter in effect, granting to any third party any right to use any trademark now or hereafter owned by any Grantor or that any Grantor otherwise has the right to license, or granting to any Grantor any right to use any trademark now or hereafter owned by any third party, and all rights of any Grantor under any such agreement (collectively, the "Trademarks Licenses"), and (c) all Proceeds and products of each of the foregoing and all accessions to, substitutions and replacements for, and rents, profits and products of, each of the foregoing (clauses (a), (b) and (c)), collectively, the "Trademark Collateral"). Notwithstanding anything else contained in this Section 2 to the contrary, Trademark Collateral shall not include, and in no event shall the security interest granted under this Section 2 attach to, any Excluded Assets, including any Trademark application filed in the U.S. Patent and Trademark Office on the basis of the applicant's intent-to-use such Trademark unless and until evidence of use of the Trademark has been filed with, and accepted by the U.S. Patent and Trademark Office pursuant to Section 1(c) or Section 1(d) of the Lanham Act (15 U.S.C. § 1051, et seq.), to the extent that granting a security interest in such Trademark application prior to such filing and acceptance would adversely affect the enforceability or validity of such Trademark application or the resulting trademark registration.

SECTION 3. **Purpose.** This Agreement has been executed and delivered by each Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office.

SECTION 4. **Acknowledgment.** Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Notes Secured Parties with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Subsidiary Security Agreement, the terms and provisions of which (including the remedies provided for

therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the Subsidiary Security Agreement, the terms of the Subsidiary Security Agreement shall govern.

**SECTION 5. Counterparts.** This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic imaging means (e.g., via electronic mail in .pdf form) shall be effective as delivery of a manually executed counterpart of this Agreement.

**SECTION 6. Governing Law.** THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.


**SECTION 7. Intercreditor Agreements.** Notwithstanding anything to the contrary herein, the rights and remedies of the Notes Collateral Agent and the Notes Secured Parties hereunder, are subject to, and restricted by, the provisions of the Split Priority Intercreditor Agreement and each other intercreditor agreement entered into in accordance with the Indenture (and to the extent any term of this Agreement conflicts with or is inconsistent with the terms thereof, the terms of the Split Priority Intercreditor Agreement and, to the extent applicable, each such other intercreditor agreement, shall, in each case, control).




