RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of January 31, 2020, is made by **Wilmington Trust, National Association**, as administrative agent ("**Administrative Agent**").

WHEREAS, **Southcross Energy Operating, LLC**, a Delaware limited liability company ("**Grantor**"), and Administrative Agent (as successor agent to Wells Fargo Bank, N.A.), are parties to that certain Trademark Security Agreement (the "**Agreement**") dated February 25, 2016, and recorded at the U.S. Patent and Trademark Office on February 25, 2016 at reel/frame number 5739/0746; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;


WHEREAS, pursuant to the Agreement, Grantor granted to Administrative Agent a security interest in all of the Grantor's right, title and interest in, to and under the Trademarks (as defined in the Agreement), including, without limitation, all of Grantor's right, title and interest in and a continuing lien on the Trademarks listed on Schedule I of the Agreement (attached hereto and made a part hereof as Schedule I) and the other Collateral (as defined in the Agreement) set forth therein; and

WHEREAS, Administrative Agent now desires to release its security interests granted pursuant to the Agreement in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Collateral and (ii) any and all other rights it may have under the Agreement.
